Once you have submitted the required information, you will receive another email with a payment link directing you to SafePay. The cost for the DBS check is £10.50. Your application will not proceed until payment is received.

After you have received your paper DBS certificate, you will have 28 days to register for the FREE update service. If you register you won't have to require any further DBS Checks, and this will mean your DBS is continually up to date .
